ABSTRACT



One of the things that causes the younger generation's low interest in history and politics is because at school they consider history lessons to be boring and uninteresting subjects because they have to memorize past events, names of kingdoms and year numbers. Literary imagination about independence even preceded and provided inspiration for independence movements which became the agenda of political movements in the future (Latif, 2009: 12-13). Literature cannot be separated from the history and politics of Indonesia. The presence of literature in the past has awakened the nation's intellectuals to become a nation that must be free from colonialism. The struggle of the Indonesian people was also accompanied by progress in the field of literature. Literary works containing history and politics must not be written based solely on the author's imagination. This literary work is formed based on a story which cannot be separated from its preparation based on factual events that occurred.

So far, many Indonesian literary works contain political history based on true stories. For example, the novel "Tenggelamnya Kapal Van der Wijck", which is a famous Indonesian historical novel by Buya Hamka. A novel set in the colonial period and telling the story of a love triangle between Zainuddin, Hayati, and Aziz, and depicting the erosion of values and traditions by European modernity.

Students' thinking patterns regarding history and politics can develop through learning literary appreciation, namely by reading and analyzing literary works. Through novel analysis, students have ample space to explore and understand a literary work in depth, both in expressing, developing and expressing ideas, being creative and increasing understanding of the content of the literary work. Through reading activities, students will be able to understand the content and values in literary works and use it as a means to develop their mindset so that students are able to become human beings who have good character, are able to survive and adapt to the social environment, especially understanding how history works. and politics in everyday life in his country. And have certain knowledge and mindset regarding history and politics in their own country.

Another problem that arises is students' low interest in reading literary works, especially those with heavy themes such as history and politics. Reading is often considered a boring and sleepy activity. Reading works is generally done by students only because they receive a learning assignment from the teacher, it is not an activity that they are interested in or a necessity because it has become a hobby. In this regard, because interest in reading is still low among students, their understanding of the content of the reading will be lacking. In fact, reading literary works, especially those with historical and political themes, will have an internal influence on students to be open-minded, broad-minded, and have an attitude towards life towards history and politics. This is in accordance with psycholiterary theory, especially





regarding reader psychology. Reader psychology itself is a type of study and part of literary psychology which focuses on readers of literary works outside of the author, who when readers read and interpret literary works experience various mental situations as an influence from the literature they read.

According to Wiyatmi (2011:56-57), Reader psychology is a type of literary psychology study that focuses on readers, who when reading and interpreting literary works experience various psychological situations. The subject of study in reader psychology are readers who actually read, appreciate and interpret literary works. As humans who have psychological aspects, when reading, appreciating and interpreting the literary works they read, the reader will communicate between interactions and dialogue with the literary works they read.

The communication referred to in Wiyatmi's theory can produce several psychological situations that occur to the reader internally, namely something that can be in the form of emotions that are released while reading or afterwards. For example, when reading a literary work, the reader will feel various feelings, ranging from happiness, sadness, emotion, anger, or crying because their soul has been touched by the depiction of experiences and stories that emerge from the characters in the literary work.

Belong to Wicaksana's (2018:3), literary works are able to influence readers through the moral messages conveyed by the author. This is obtained through self-reflection. Literary works are a reflection of the psychology contained in the characters created by the author. This causes readers to experience psychological problems when they start to get involved in. Then good literary works produce character values in them. Readers can emulate existing character values and apply them in everyday life. Suprapto, et al (2013:4). From the two opinions above, it can be concluded that a literary work, when studied by a reader, can have an indirect influence on the reader, either through implicit moral messages or from the story and character depiction of the characters.

Based on the explanation above, it can be seen that a literary work can have an internal influence on the reader through several things that appear in the literary work such as the story, characters, message, etc. In this research, related to students' low interest in reading and lack of knowledge of political history, the author will explore research regarding the influence of reading literary works containing political history on the mindset of class XII students in assessing Indonesian history and politics through literary works. Meanwhile, the novel chosen to be given to students was the novel "Laut Bercerita" by Leila S. Chudori. The choice of this

METHOD



RESULT AND DISCUSSION

Result

The novel "Laut Bercerita" by Leila S. Chudori is a book created and told in several story chapters. In the first act of the novel, which is set in 1998, it tells the story of a student named Biru Laut, the young man was kidnapped by a group of unknown people and he did not even know about it. Together with three friends in his group, Biru Laut was taken to an unknown place and then locked up for some time with various incidents ranging from: being held captive, interrogated, beaten, kicked, hanged, to being electrocuted so that Biru Laut et al would reveal the mastermind behind the group's movements. they were in the activist and student movements at that time. Two years after Biru Laut mysteriously disappeared and was not found, his sister Asmara Jati and the Missing Persons Commission Team and Biru Laut's lover, Anjani, tried to find traces of those who were missing. Likewise, the parents and wives of activists who were





also missing also demanded clarity on the fate of their family members. Meanwhile, from the quiet seabed, Biru Laut told the world about what happened to him and his friends.

Reading as part of literacy is an intellectual activity which can certainly influence the reader's mindset significantly. Historical-political novels in particular offer a unique perspective on past events presented through the eyes of historical or fictional figures involved in those events. Novels that discuss political issues wrapped in history can provide new and in-depth understanding of the dynamics of social and political life in a society.

The results of research conducted on a group of reading enthusiasts at the Katapang Literacy Community (Kolika) showed that reading historical and political novels had a positive and indirect effect on the mindset of the research subjects. Based on the research results, it can be explained that the influence of reading historical and political novels through the novel "Laut Bercerita" by Leila S. Chudori is as follows.

Increased Understanding and in-depth Knowledge of History and politics

Apart from the interesting story themes, through historical and political novels, readers can of course develop a deeper understanding and knowledge about historical events and their context. In the next stage, readers will be able to relate past events in the story to their impact on current social, political and cultural conditions.

Apart from that, novels and stories with historical-political nuances often depict situations and atmospheres of the complexity of power relations, ideological conflicts, and political dynamics that exist in society. Through the activity of reading novels on this theme, readers can gain a deeper understanding of how history occurs and takes place, how public policies are made, how power is exercised, and the impact of history and politics on everyday life.

After reading historical-political novels, readers from the Kapatang Literacy Community (Kolika) gain understanding and knowledge about political history. Among them is increasing insight into the background and history of the political turmoil in the reform era in 1998 which involved the student movement which at that time succeeded in besieging the Republic of Indonesia DPR Building and voicing the resignation of the president's power at that time which was filled with rampant corruption, collusion and nepotism.



Reflection on Values and Morals and Social Conditions

The stories contained in historical novels often convey messages about universal values such as justice, friendship, courage, and so on. Readers of historical novels will respond by reflecting these values in their daily lives.

Meanwhile, political novels often reflect the social and political realities of a certain period. Through their stories and characters, these novels can raise awareness of relevant social problems, such as economic inequality, corruption, or ethnic tensions. The violations of humanity with kidnapping and torture depicted in the novel "Laut Bercerita" provide a reflection of the thoughts of readers in the Katapang Literacy Community (Kolika) that violations of humanitarian values and principles are violations of humanity that should be addressed and not repeated in real life on a daily basis. 
3. Friendship and Solidarity
