Language studies must begin to be improved in studies that understand the social processes such as domination, hegemony, ideology and others. By continuing to study language to this stage, linguistic analysis is expected to be able to provide broader benefits for

people's lives. Based on this thinking, Fairclough offers a critical discourse analysis model better known as the Fairclough three-dimensional AWK framework.

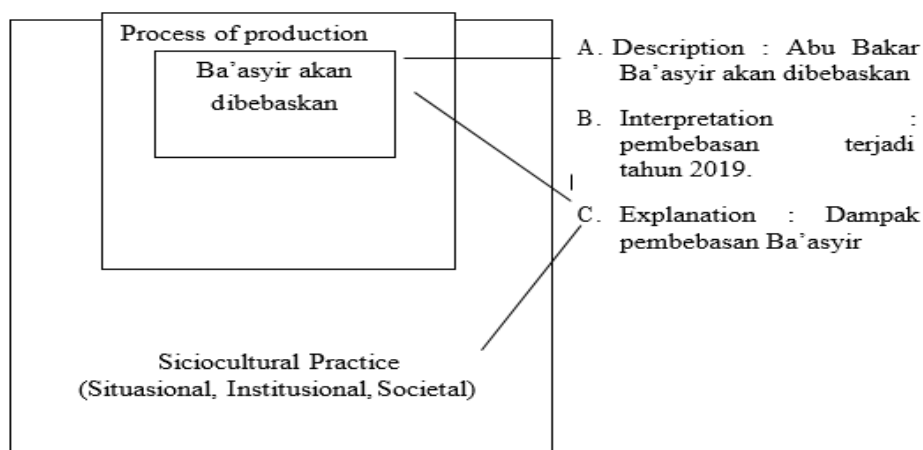
Coverage on 2 Online Media
